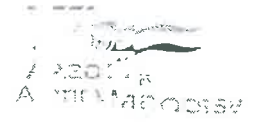

Sir,

RVS Medical Trust Homoeopathic Medical College, Kumarankottam Campus, Kannampalayam, Sular, Coimbatore-641402, Tamilnadu is functional since 2001 and has applied for conducting permission for **BHMS course with 50 seats for the academic year 2024-2025**. The college has submitted the Part I information in which the entire functional profile has been narrated. Medical Assessment and Rating Board has examined the profile of the college as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under the NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfalls as per MSR requirements:

IPD and OPD case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, Phone number. All follow up attendance should be recorded on the case records. Case sheets shall be maintained with complete case history, analysis and evaluation and repertorisation and made available in Medical Record Room for academic purpose of students and follow up of patients.

Considering the above observations and facilities available, MARBH has decided to issue **Conditional permission to RVS Medical Trust Homoeopathic Medical College, Kumarankottam Campus, Kannampalayam, Sular, Coimbatore-641402, Tamilnadu for conducting UG (BHMS) course with 50 UG seats for the academic year 2024-2025.**

All deficiency noticed shall be rectified within a period of one month and compliance report shall be submitted for verification.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the intake capacity of 50 UG seats shall be treated as All India Quota. The counseling for seats under All India Quota shall be conducted by respective Counseling authority of State/UT Govt as designated by Central Government/NCH and counseling

for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

**Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.**
